Rock stars of Timmins business celebrated at 2018 Nova Awards

The rock stars of local business took center stage at the McIntyre Arena on May 10, joined by a crowd of more than 700 people in celebration of the 2018 Nova Business Excellence Awards.

Hosted by the Timmins Chamber of Commerce, the sold-out gala once again cemented its status as the largest business awards event in northern Ontario, with 16 local firms and entrepreneurs honoured across a range of categories.

The concert theme of “Business Takes the Stage” was used throughout the evening to help showcase the many ways that entrepreneurs are Timmins’ unsung rock stars, said Jamie Clarke, president of the Timmins Chamber of Commerce.

“The Nova Awards are an important reminder of the many ways that our businesses work in harmony to make Timmins truly great,” said Clarke.

“All of the entrepreneurs featured this evening, from the finalists to the recipients, truly deserve our applause, and it’s clear from tonight’s packed house that Timmins clearly agrees.”

Chamber past president Art Pultz once again served as the event’s emcee and front man, marking the 15th time in the event’s 16-year history he has overseen the awards ceremony. Pultz helped to highlight the slate of more than 40 finalists who were

honoured throughout the evening.

The Nova Awards recipients were carefully selected from a record-breaking 160 nominations by a committee of six independent community judges. These judges determine the award recipients based on the quality of the submissions; to ensure the validity of the results, this is done without any input or influence from the Chamber Board of Directors or staff. This independence also helps to make the event one that truly belongs to the community, said Clarke.

“They might not be putting out Top 40 hits or selling out cross-Canada tours, but we can clearly see from these honourees that Timmins’ business owners and entrepreneurs deserve just as much recognition, given the incredible things they do in our community. Each one helps make Timmins a better place to work, live, and play, and we’re thrilled to help shine a spotlight on their performance.”

Elections heating up for Timmins Chamber board of directors

Voting is now officially open for the Timmins Chamber of Commerce’s 2018-2019 Board of Directors election, and there’s still plenty of time for members to ensure their voices are heard.

Fifteen members have been nominated to fill six open slots for the coming Chamber year. They are running for the right to represent the Chamber membership and the greater business community on the 21-member board.

Each of the Chamber’s voting members still has the opportunity to cast their ballot, with the elections due to close on July 10 at 5 p.m.

Board members also chair each of the Chamber committees, matching their expertise with those of the participating committee members to help determine ways to improve the business climate through action plans.

To help strengthen the members’ collective voice on these subjects, the Timmins Chamber also works collaboratively with countless partners – government representatives, community organizations, industry stakeholders – on building consensus and support.

Voting for your 2018-2019 board

Once again this year, voting members of the Timmins Chamber are offered electronic means to cast their ballot. Each voting member who has registered an email address with the Chamber has received an email with voting instructions from the Chamber’s election software. This includes a unique link that takes the voting member to a secure site where they can review nominees’ biographies and place a vote in confidence.

Members without an email address on file, or whose emails could not receive their digital ballot – approximately five percent of the total membership – have been sent a print ballot.

Business leaders call for Ontario natural resources strategy

Days before Ontarians headed to the polls, representatives from Aboriginal business, mining, prospectors, forestry, local government, and the broader business community called for the creation of a provincial natural resource strategy with specific actions, following a roundtable discussion hosted by the Timmins Chamber of Commerce on May 28.

"The natural resource sector represents an integral component of our economy, and the Timmins Chamber has long stood as a strong advocate for the removal of barriers to its competitiveness," said Jamie Clarke, president of the Timmins Chamber of Commerce.

"We're extremely pleased to be able to work alongside these important partners from throughout the province to address these issues collaboratively, and we look forward to advancing these priorities with the next provincial government."

The need to develop this strategy was the primary recommendation that emerged from the landmark meeting, which was convened at the Timmins Chamber to stimulate thinking on priorities and opportunities for growth in Ontario's resource sector. It included the following participants:

These cross-sector roundtable participants concurred that Ontario businesses face many challenges that need to be addressed to support economic growth and stability for the province. Resource industries are the backbone of Ontario's

economy, representing an important source of greater living standards and well-being for all; however, the cumulative regulatory and financial burden associated with this sector is threatening its competitiveness.

"A strong natural resources sector in Ontario provides skilled jobs for northern communities, including Aboriginal communities, and helps to ensure a prosperous economy," said Rocco Rossi, Ontario Chamber of Commerce President and CEO. "At a time when Ontario is facing a skills mismatch, our next government must take bold action, working with the natural resource

and northern communities, to address current challenges and provide a pathway forward for industry leadership in the global marketplace."

With the resources sector keen to engage with government on solutions to address some of the unique challenges facing Northern Ontario, the scope and breadth of the issues will require collaboration from several provincial ministries. By developing a natural resource strategy, government would ensure coordination of efforts across ministries, stakeholders and communities.

To that end, the group is recommending that the incoming government consider the following as part of a broader natural resource strategy:

- Reduce Energy Costs
- Address Regulatory and Administrative Burden
- Improve Skills Training and Talent Availability
- Build Capacity in Aboriginal Communities
- Support Northern Ontario Infrastructure

"A strong resource sector can help Ontario deliver on key priorities, including securing and diversifying procurement opportunities, enhancing investments in innovation and strengthening relations with the Province's Indigenous Peoples," said JP Gladu, President and CEO of the Canadian Council of Aboriginal Business.

Resource companies are well-positioned to work with the government to build the capacity that will support Aboriginal entrepreneurship and community participation in the resource economy.

A government ready for bold action can strengthen Ontario's position in the global economy. Today's participants encourage all parties to consider the role a strong resources sector can play in a prosperous Ontario and will work with the next provincial government to develop a resource strategy for the benefit of all Ontarians.

Timmins Chamber secures provincial partner in fight for regional business issues

The Timmins Chamber of Commerce has secured the support of the province's largest business advocacy group to assist in pushing for change on three key regional issues, including mining and hotel taxes, and interprovincial trade.

At the Ontario Chamber of Commerce's (OCC) annual general meeting in Hamilton on April 26-29, Timmins Chamber representatives successfully urged more than 100 conference attendees to support made-in-Timmins policies designed to take action on these local priorities:

- Making it easier for Ontario businesses to operate in Quebec,
- Protecting local tourism industries from potential harm under the new Municipal Accommodation Tax, and
- Maintaining current mining tax rates.

This success means that the Timmins Chamber policies are now official policy positions of the OCC. As such, the OCC will actively use these positions to push the government for change, supported by the full weight of the 60,000 businesses represented by the organization.

"The Ontario Chamber of Commerce is an incredibly influential voice for policy at the provincial level, so their adoption of Timmins' three resolutions is a significant victory for our members and our economy," said Jamie Clarke, president of the Timmins Chamber of Commerce.

"Having these resolutions on the OCC's books

means that the organization will actively lobby for these positions with the provincial government over the next three years, allowing our members to be heard at the highest levels. These kinds of partnerships with the chamber network are crucial to protecting our business competitiveness."

This success is also significant as these resolutions were driven by the concerns and feedback of local members, said Clarke. For instance, many local businesses who attempt to diversify into nearby Quebec markets face unique regulatory barriers across a broad range of sectors. To address the issue, the Timmins Chamber resolution as adopted by the OCC asks the province of Ontario to work with Quebec officials to identify and remove those barriers, while building programs that help to foster relationship building between regional business communities.

Similar local concerns arose around the new Municipal Accommodation Tax, which the province allowed cities to levy locally as of December 2017, and which has been briefly discussed at Timmins City Council. Already having been passed by numerous municipalities across Ontario, this new "hotel tax" is applicable to local facilities that provide stays under 30 days, and it differs from the Destination Marketing Program (DMP), which it will effectively replace: whereas the DMP is a voluntary model that allows participating

businesses to help oversee how its tourism dollars

are spent, the new tax can be applied unilaterally, with no cap and no hotel oversight, and where half the revenues can go into general municipal revenues. In response, the Timmins Chamber resolution urges the province to cap the amount of tax that can be levied, and allow affected businesses to help oversee how those tax revenues are spent.

This desire to preserve the North's competitive advantage is also mirrored in the Timmins Chamber's third resolution, which simply states that Ontario should maintain mining taxes at their current rate, despite calls from various advocacy groups. With a provincial election looming, it's crucial to be able to ensure that Ontario continues to offer a stable and reliable environment in which mining companies can invest, said Clarke.

The Timmins Chamber developed these resolutions based on input from its members as well as its Government Regulation and Policy Committee. As a sign of their broader impact on Northern Ontario, the policies were also co-sponsored at the event by the Greater Sudbury Chamber of Commerce, Thunder Bay Chamber of Commerce, and the Sault Ste. Marie Chamber of Commerce.

"Given the importance that each of these issues has for our members, we're very pleased to be able to advance them at the provincial level," said Clarke. "With the Ontario Chamber network now in full support of Timmins' priorities, we look forward to

working with our partners across the province to push for meaningful change."

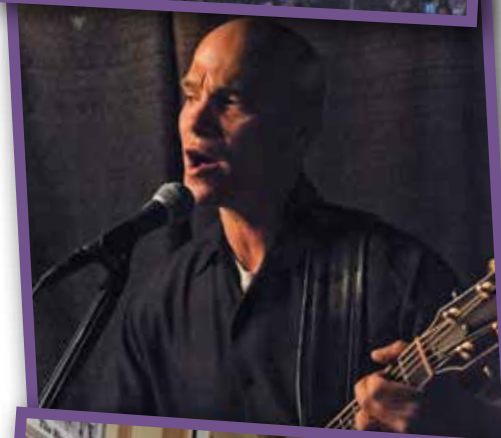

Growing number of international students looking to work, live and learn in Timmins

Deciding where to pursue post-secondary education is one of the most important decisions a student will ever make. For international students, it's also about choosing a new community to live, learn and work.

International students make up a vital part of the Northern College community. Close to 200 international students started studying at the College in the 2017-18 academic year, with most at the Timmins Campus.

With increased international recruitment efforts, a growing number of registered students are expected each year. As international student participation continues to increase, there are new opportunities to attract students to study and to stay permanently in Timmins and the surrounding area.

Most international students find it useful and necessary to work part-time while they study. Many arrive in Canada looking for accommodations throughout the summer and during the academic year.

Facilitating the process for international students to find employment and accommodations in Timmins during their studies and after graduation will contribute to our local economic, social and cultural development.

Employment Opportunities

International students with full-time registration status and a valid Study Permit are eligible to work off campus. Students may work up to 20 hours per week during the regular academic year and full-time during scheduled breaks, such as winter and summer holidays or March Break.

After graduation, students may choose to work temporarily or live permanently in Canada.

The post-graduation employment program provides graduating students with opportunities to acquire Canadian work experience. Most international students who graduate from Northern College are eligible to apply for a post-graduation work permit with a validity period of up to three years, though this depends on the length of the student's program of study.

Northern College's Employment Options Employ office in Timmins provides employment services to help job seekers find sustainable employment and employers find suitable employees. Off-Campus Student Housing

For students looking for a place to live off-campus, Northern's Online Housing site is the first point of contact between students and potential

renters and landlords. The search for off-campus housing increases in the months leading up to the start of the Fall Semester in September, as well as the start of the Winter Semester in January. To connect with future tenants, post your ads for September 2018 now at northern.on.ca/housing

Northern College also works with community members to provide a unique housing service that matches students with a host or host family. This arrangement can provide international students with a sense of home and security as they start their new life in Canada, with an opportunity to enjoy cultural, social, and recreational activities.

Community Impact

Northern College aims to make Timmins a great place to study by providing every opportunity for students to excel in their education and future careers and develop life-long connections with our city and region.

The forecasted decline in post-secondary domestic enrolment in Ontario continues to drive Northern to recruit additional students from new markets outside the traditional geographic catchment area with the goal of increasing overall enrolment.

There are significant positive impacts associated with international students studying in Timmins.

The main reason for welcoming international students to our community are the demographics

of an aging workforce. Key labour market data from Statistics Canada shows that this changing demographic, along with outmigration, will create shortages of highly skilled workers in the region.

The economic benefits of international students studying in Canada are significant. Global Affairs Canada (GAC) estimated that in 2016, international students in Canada spent around \$15.5 billion on tuition, accommodation and other expenses.
