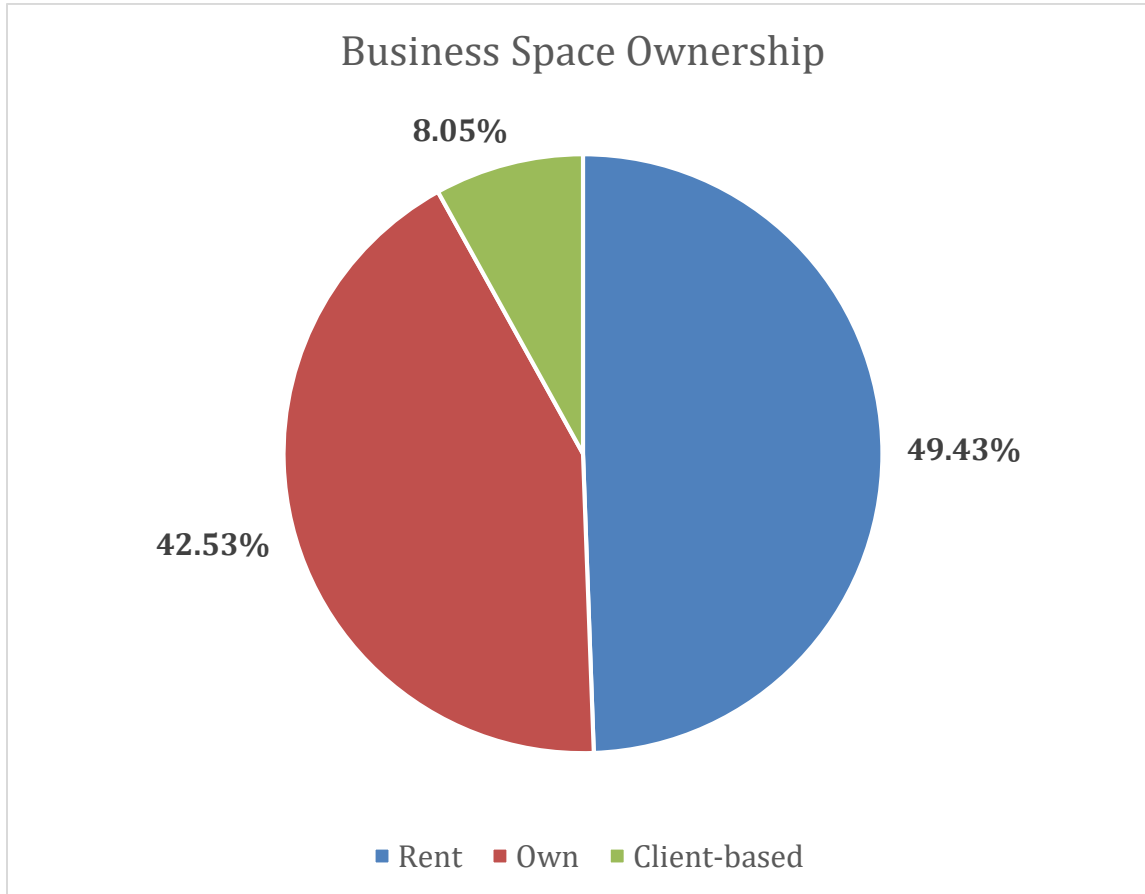

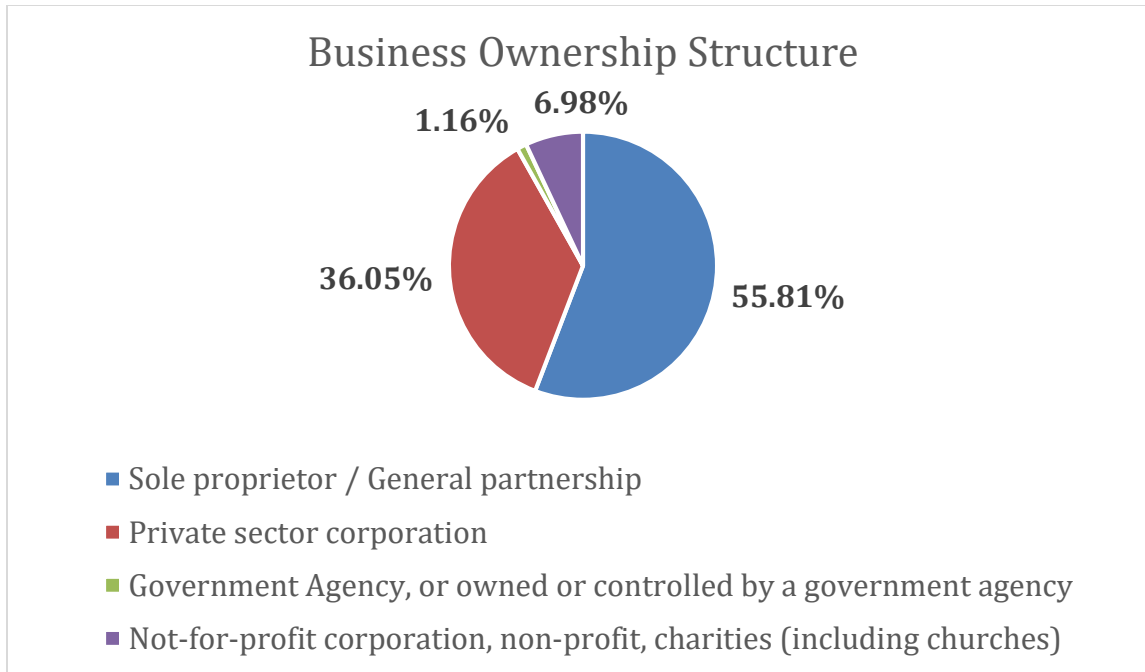

There were 87 individuals who responded to this survey between May 25-31, 2020.

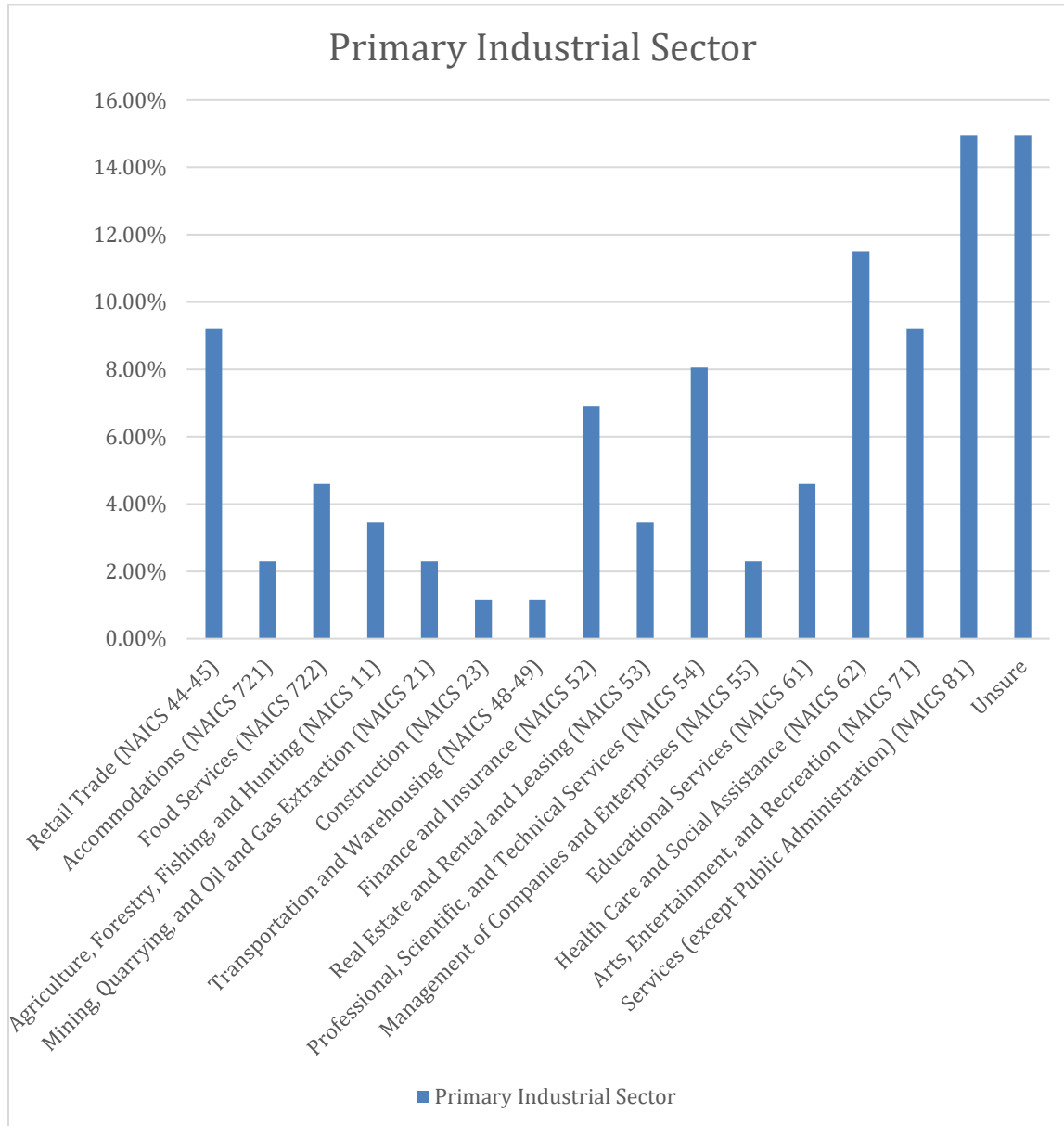
Q1. Do you rent or own the space where your organization operates?



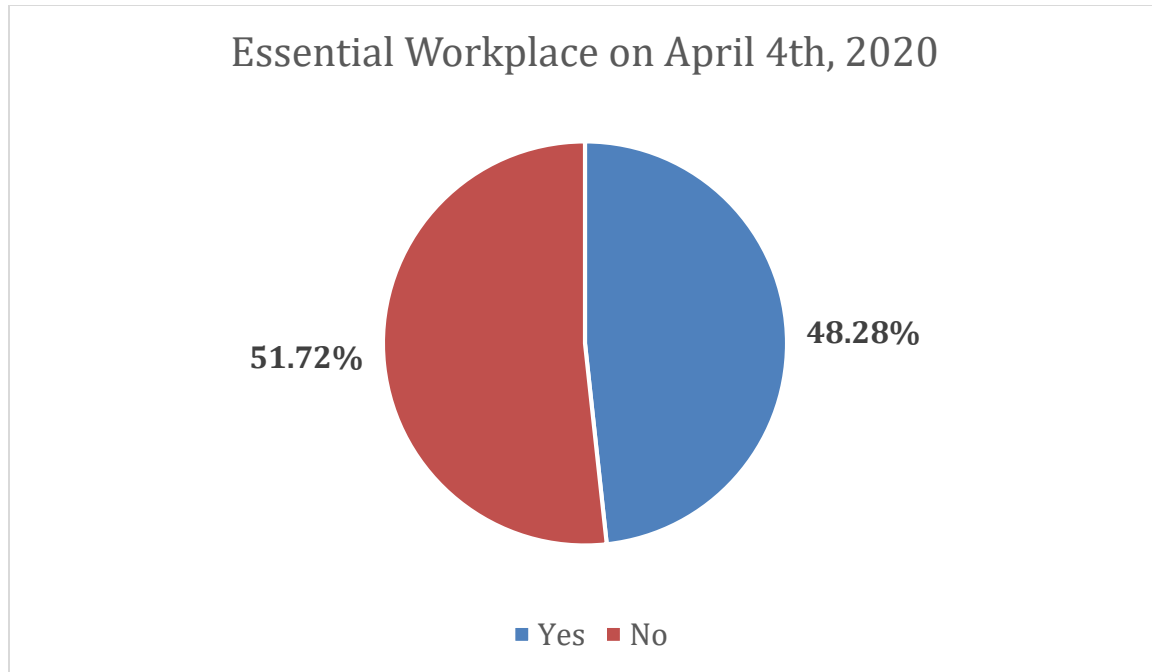
Q2. Which of the following best describes the ownership structure of your organization?



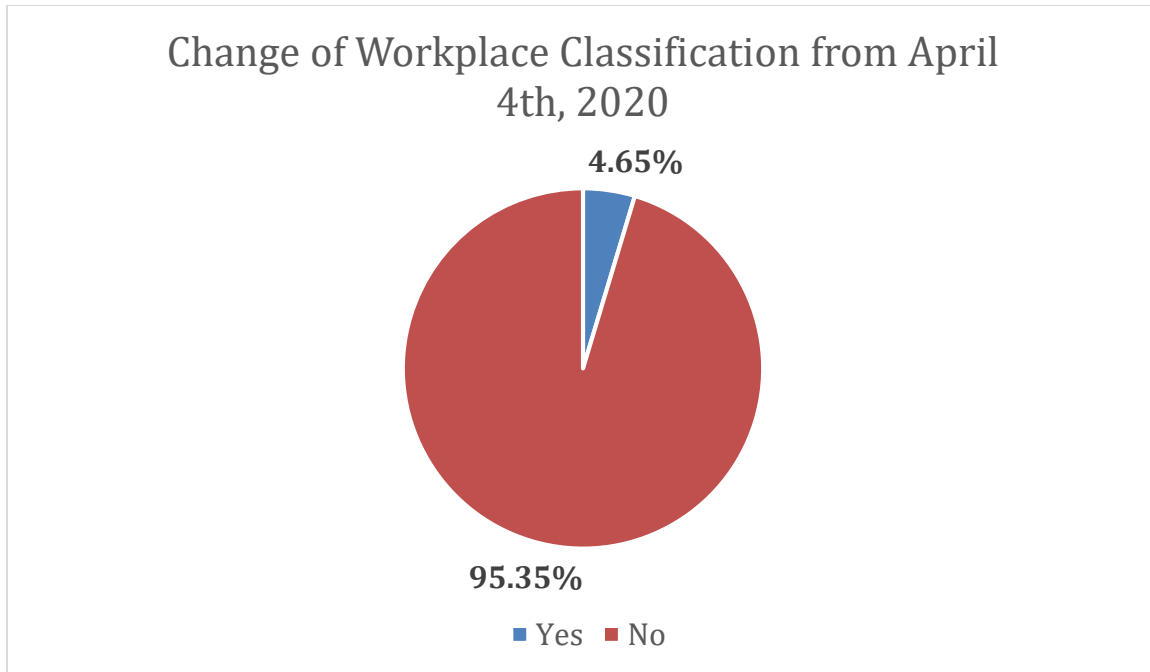
Q3. What is the PRIMARY sector of your organization?



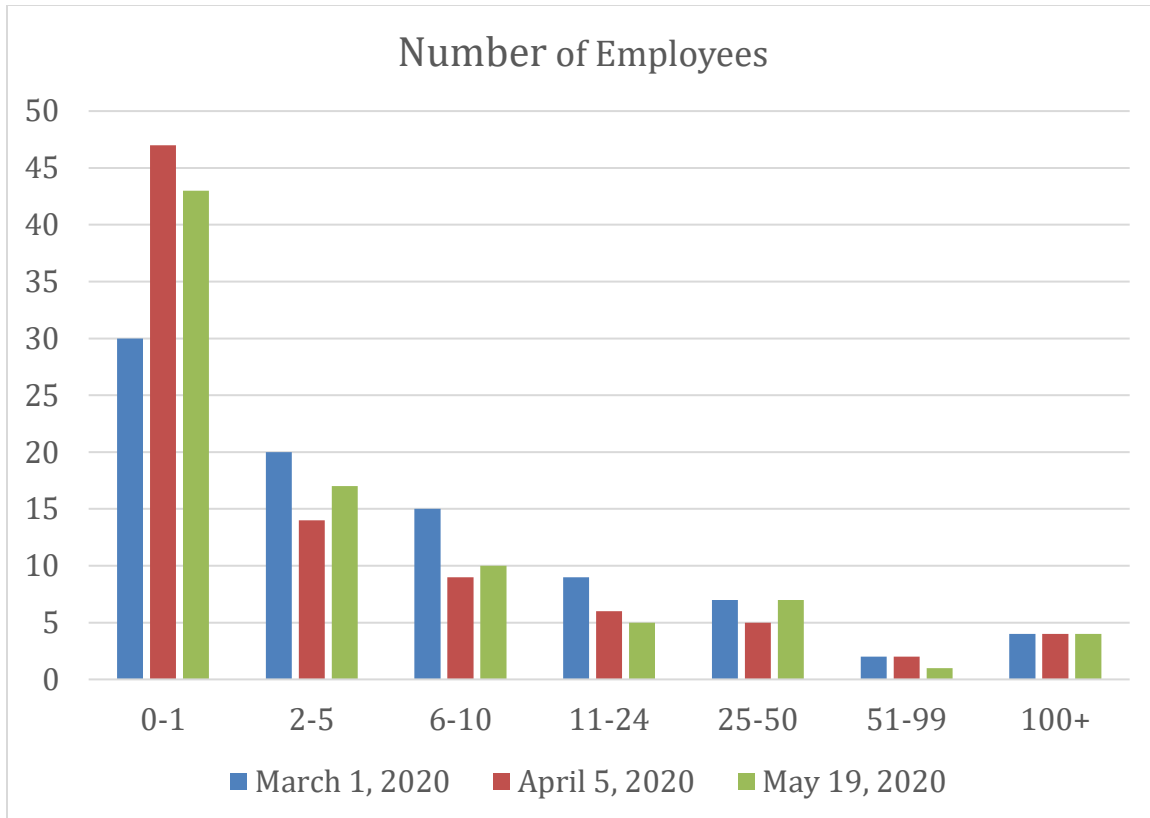
Q4. Was your organization classified as an essential workplace based on the April 4th, 2020 provincial directive?



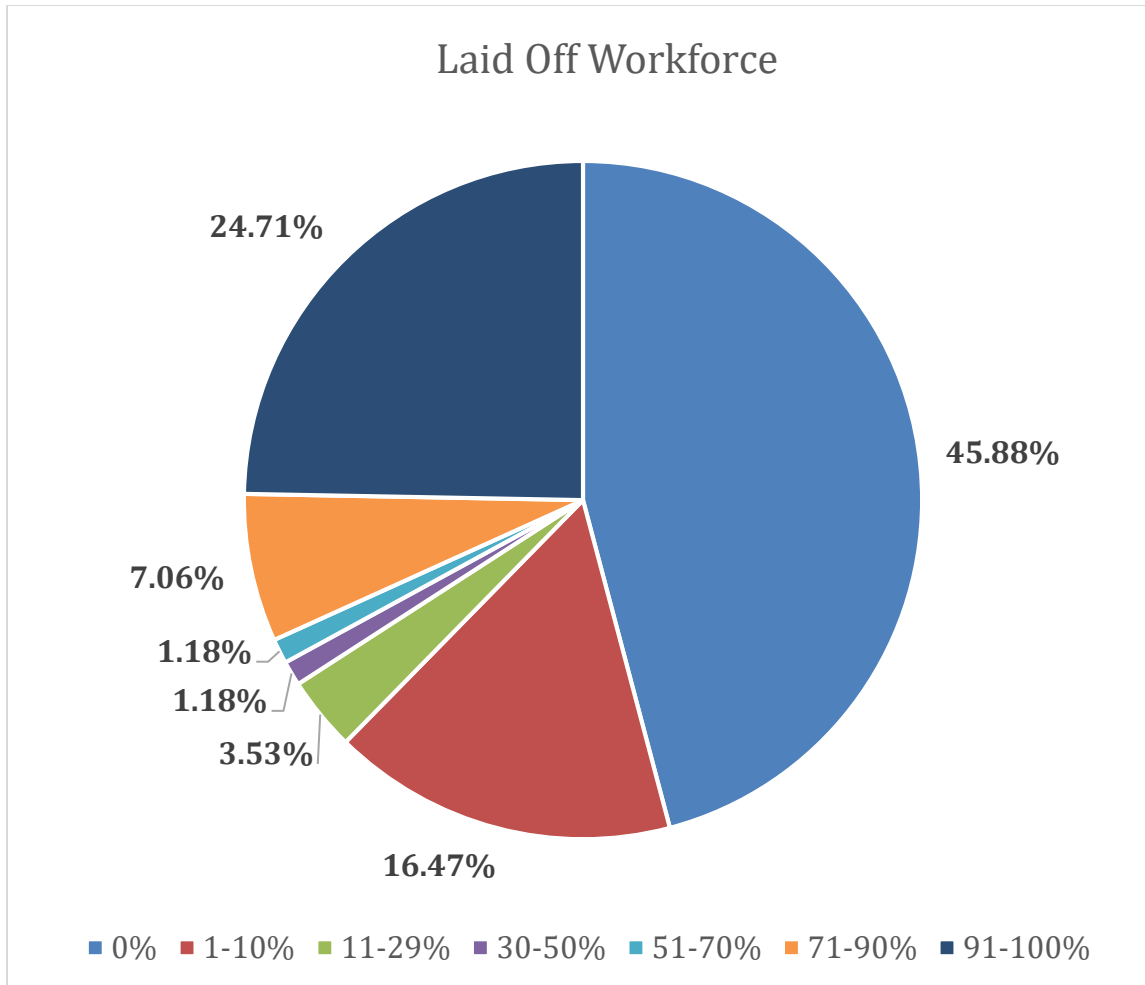

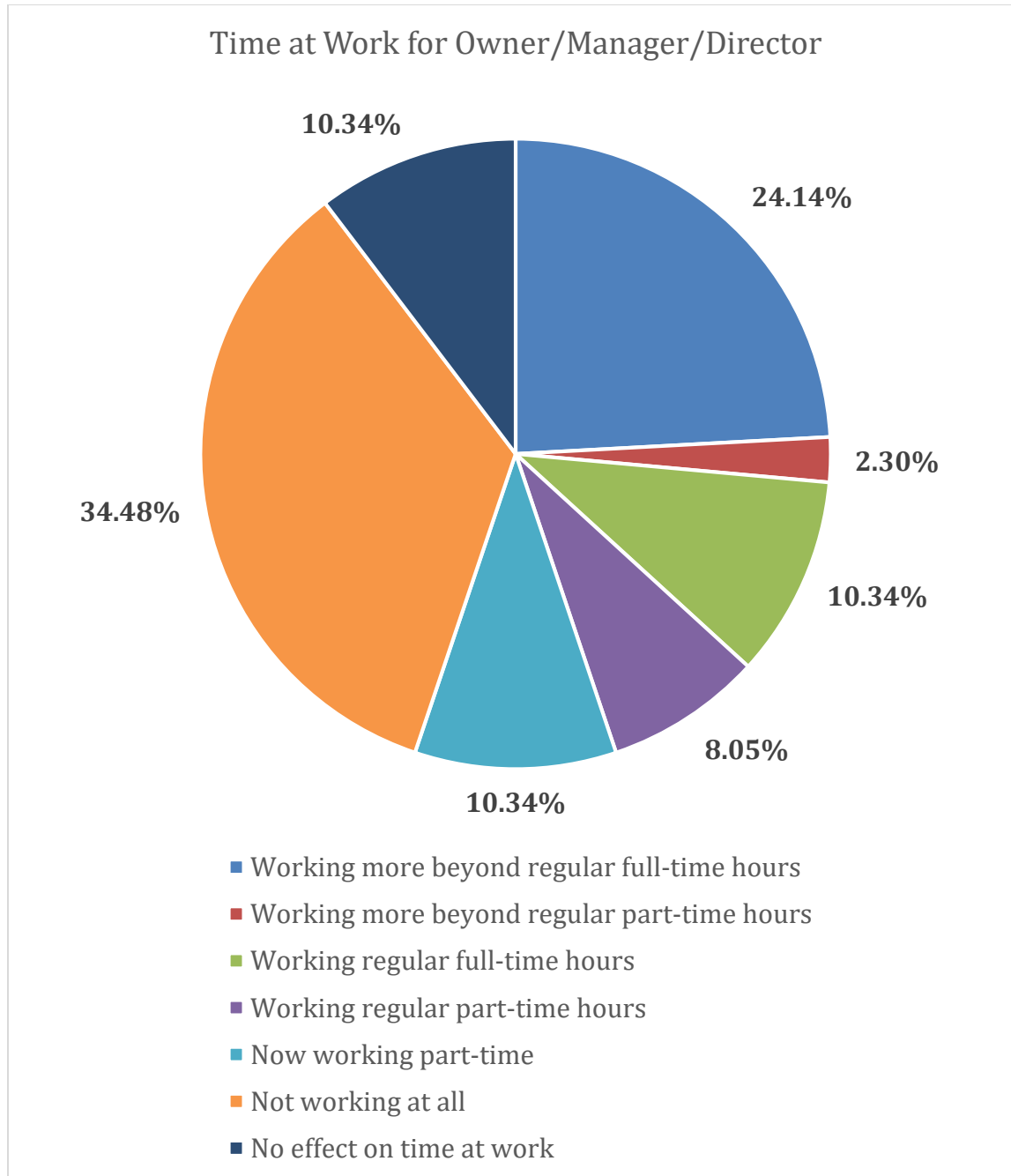

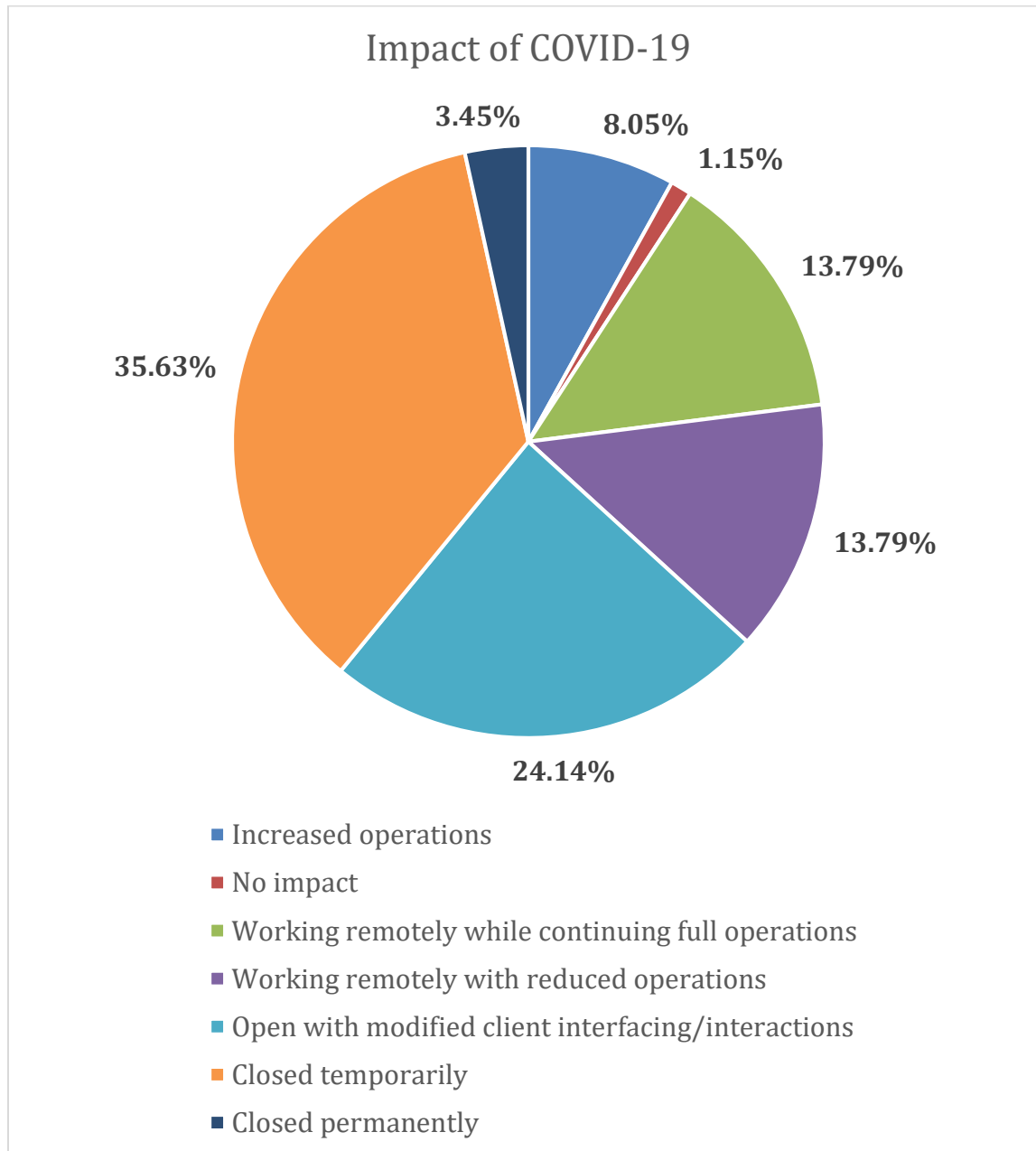

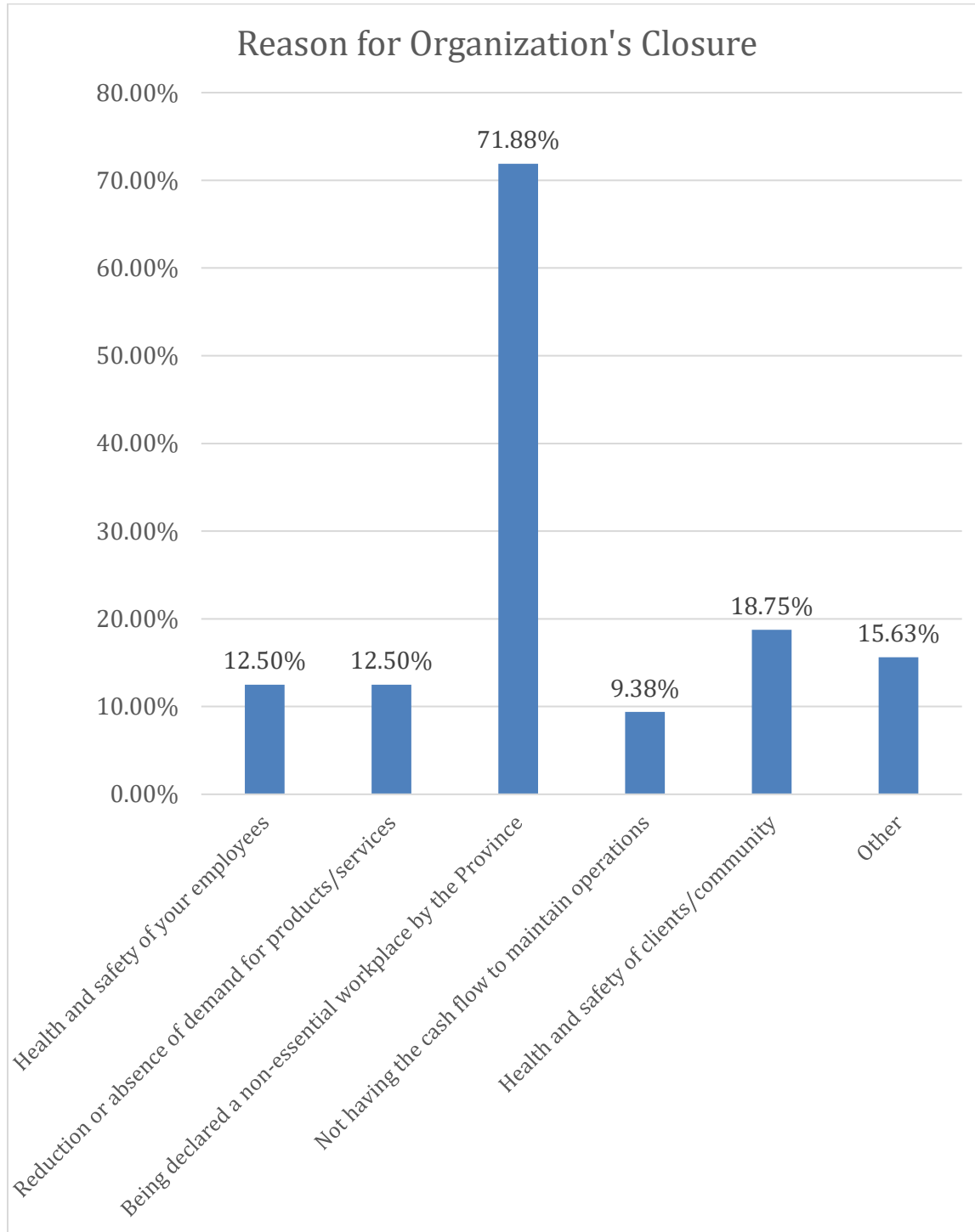

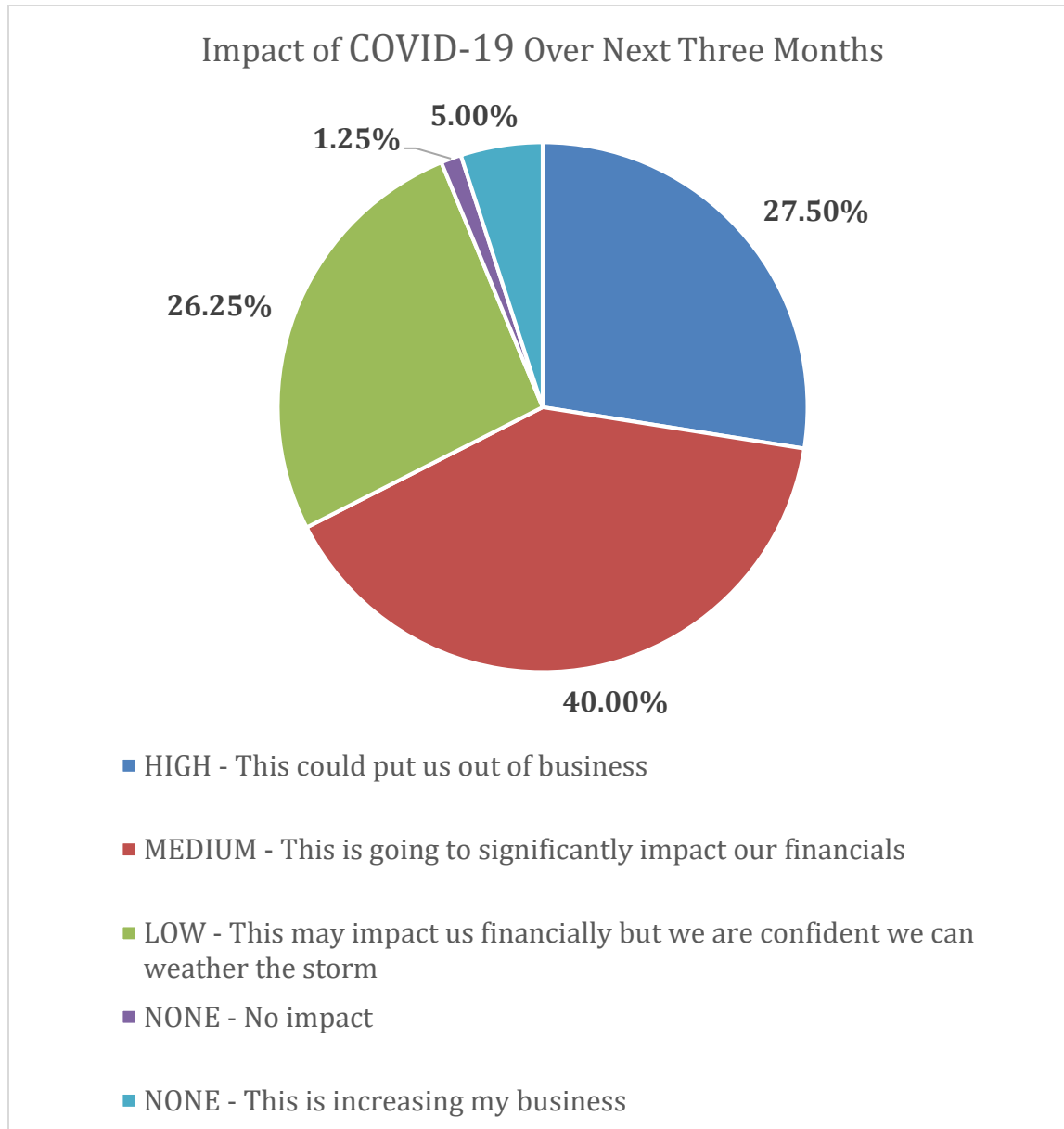

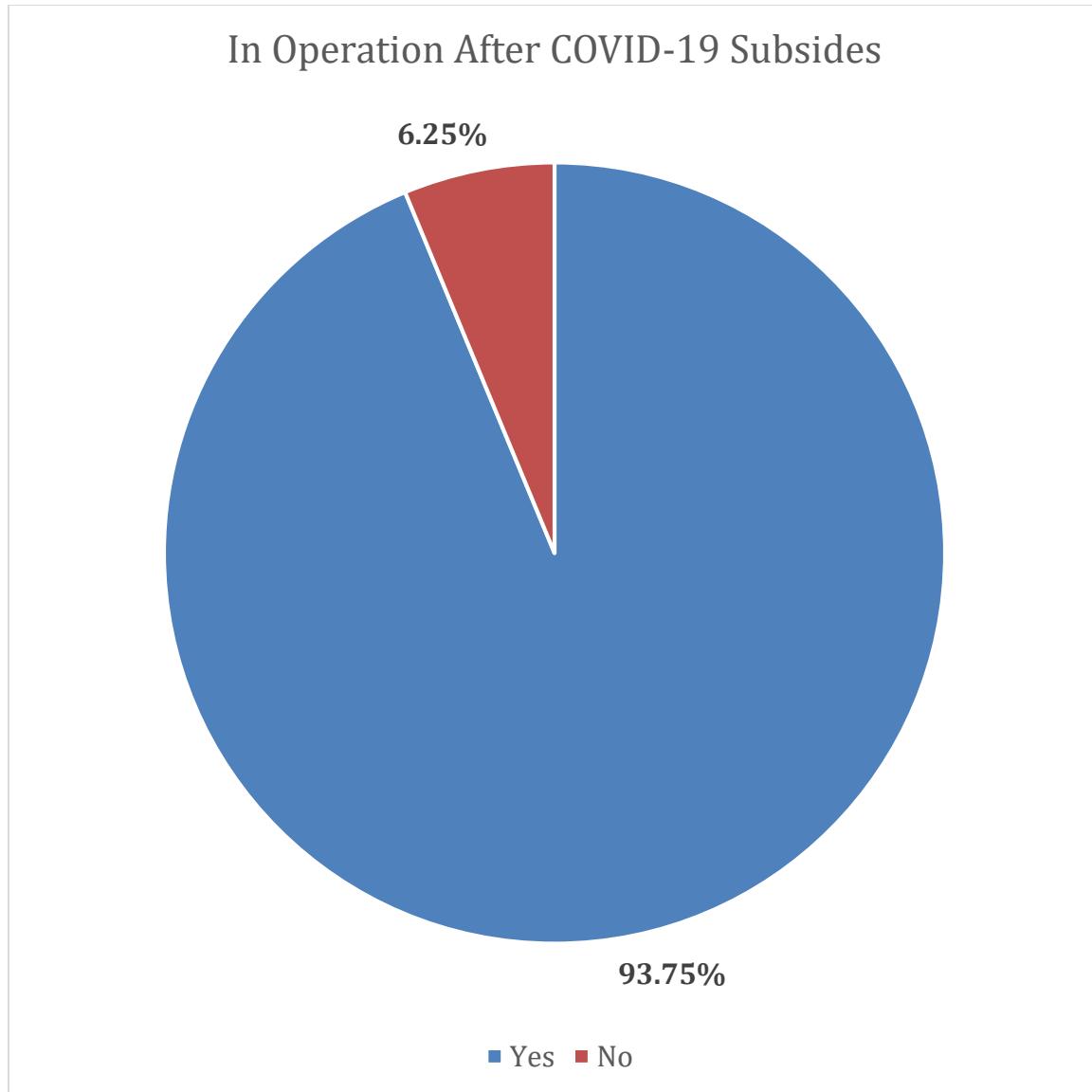

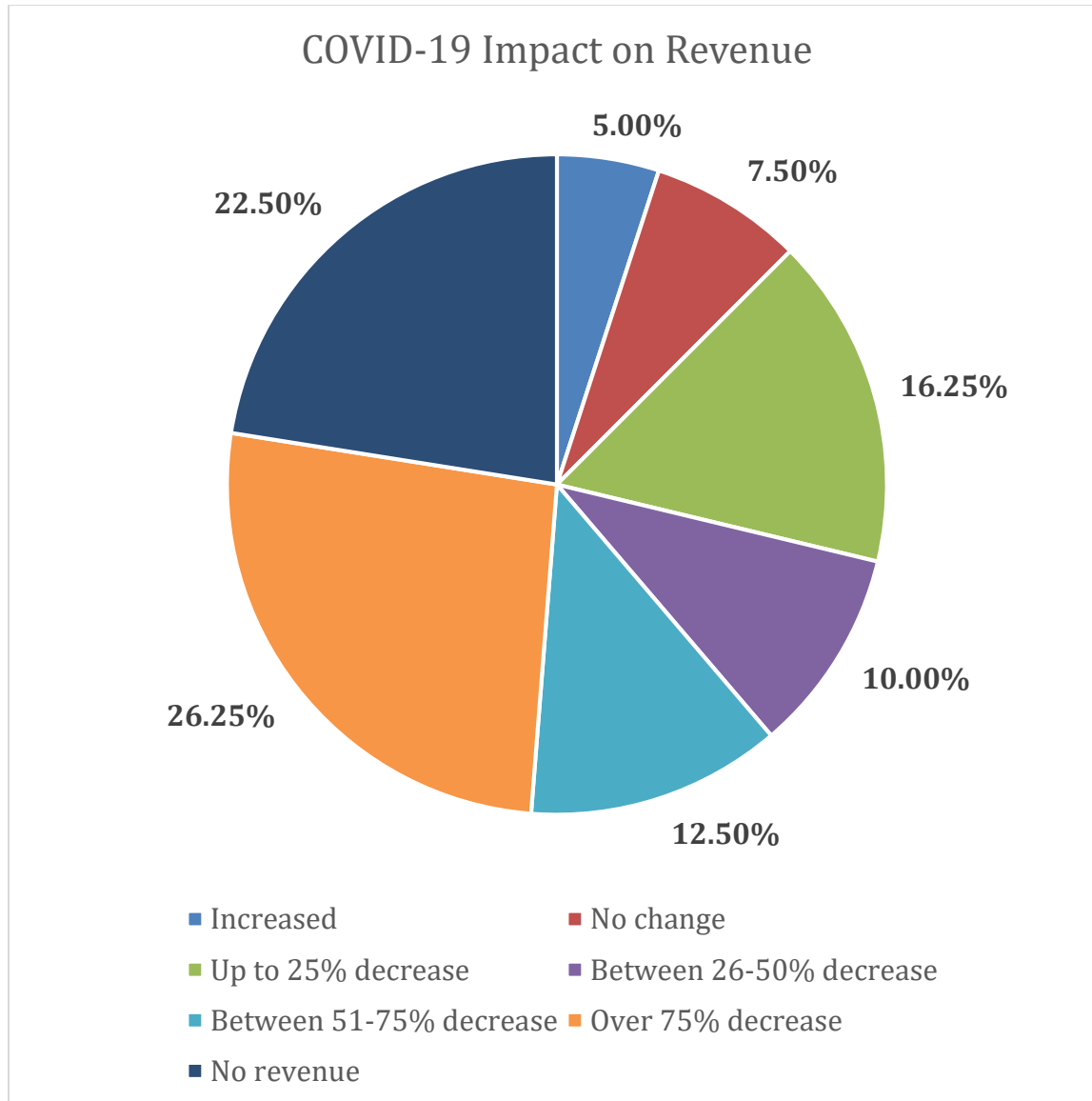

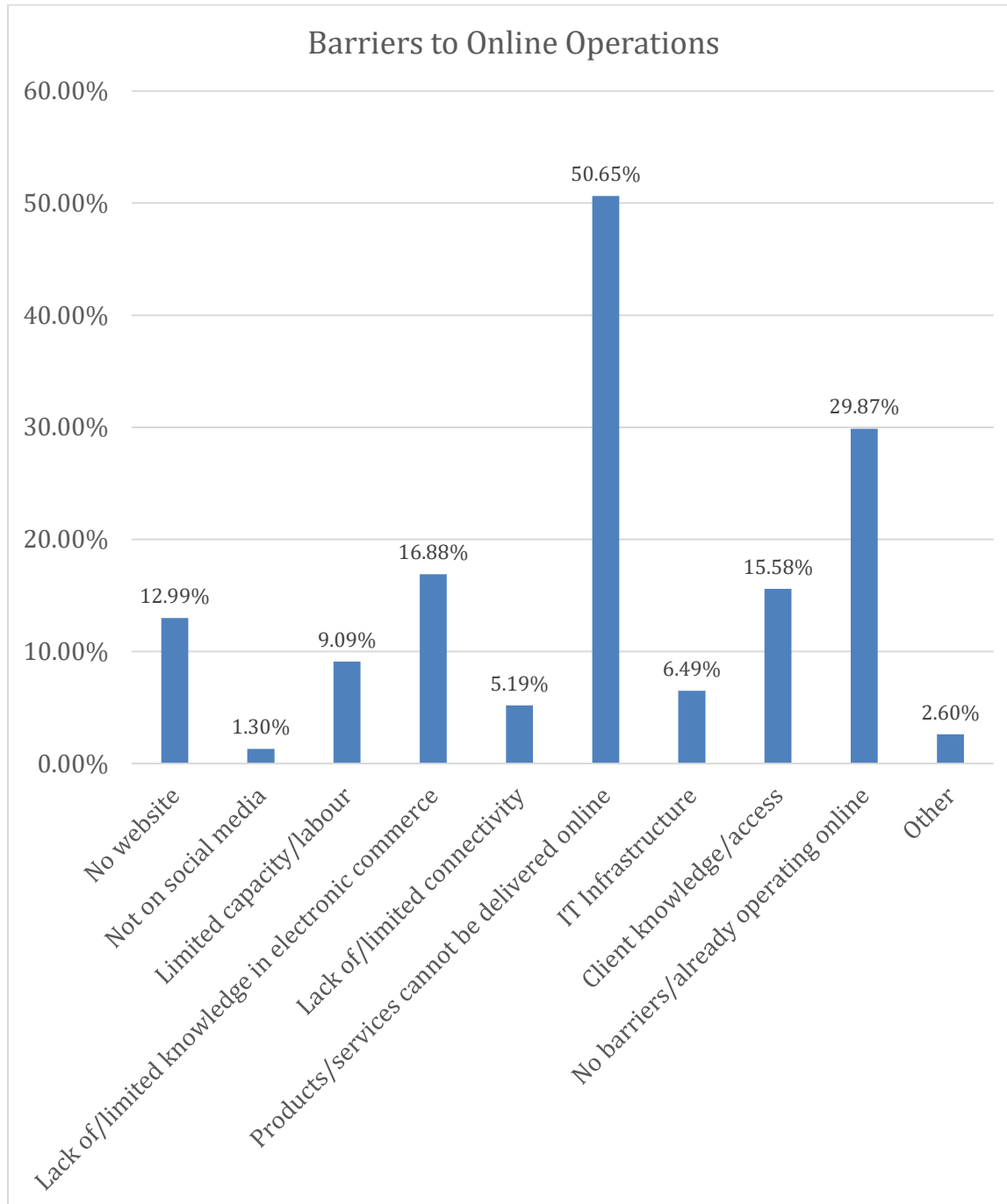

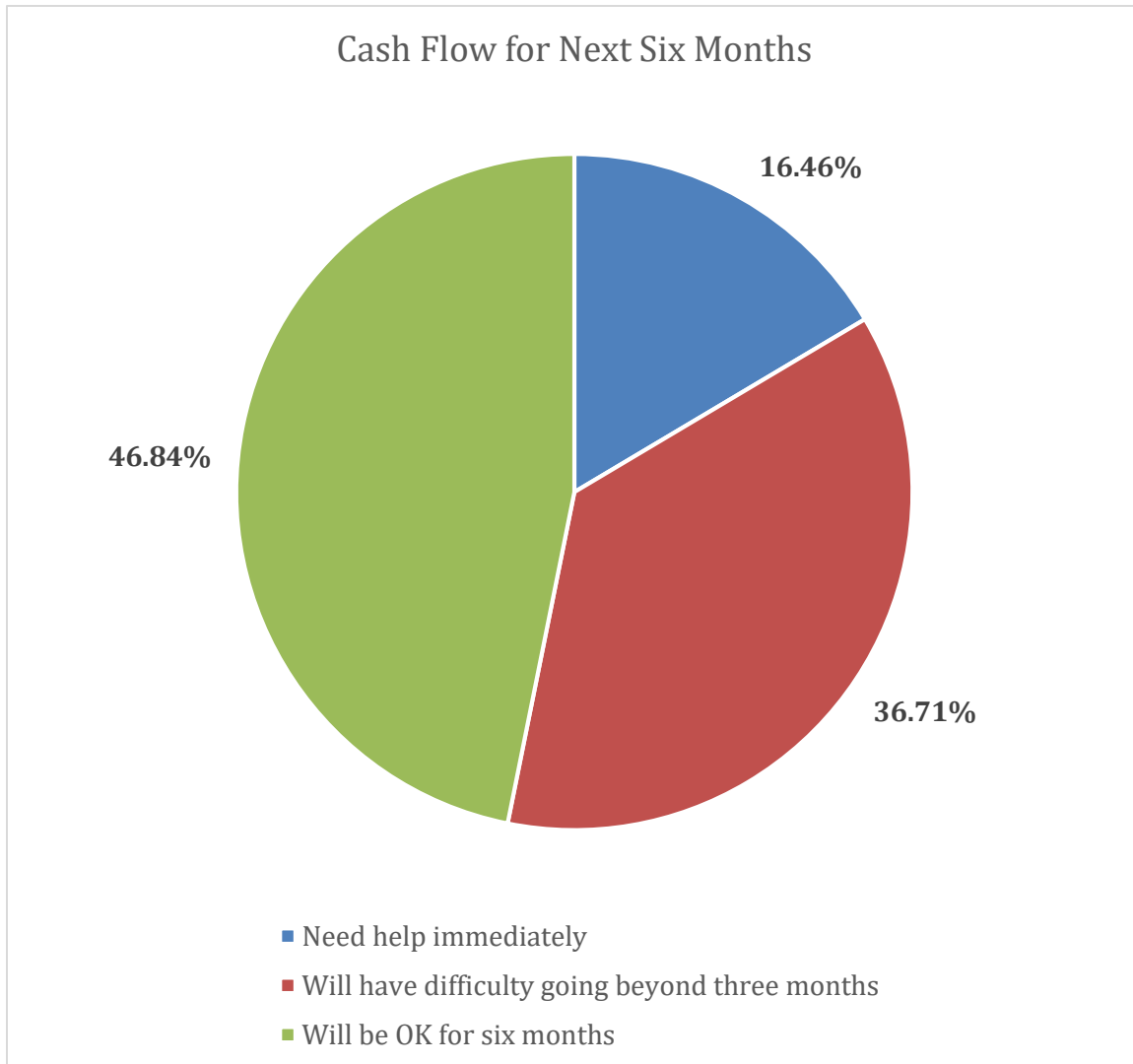

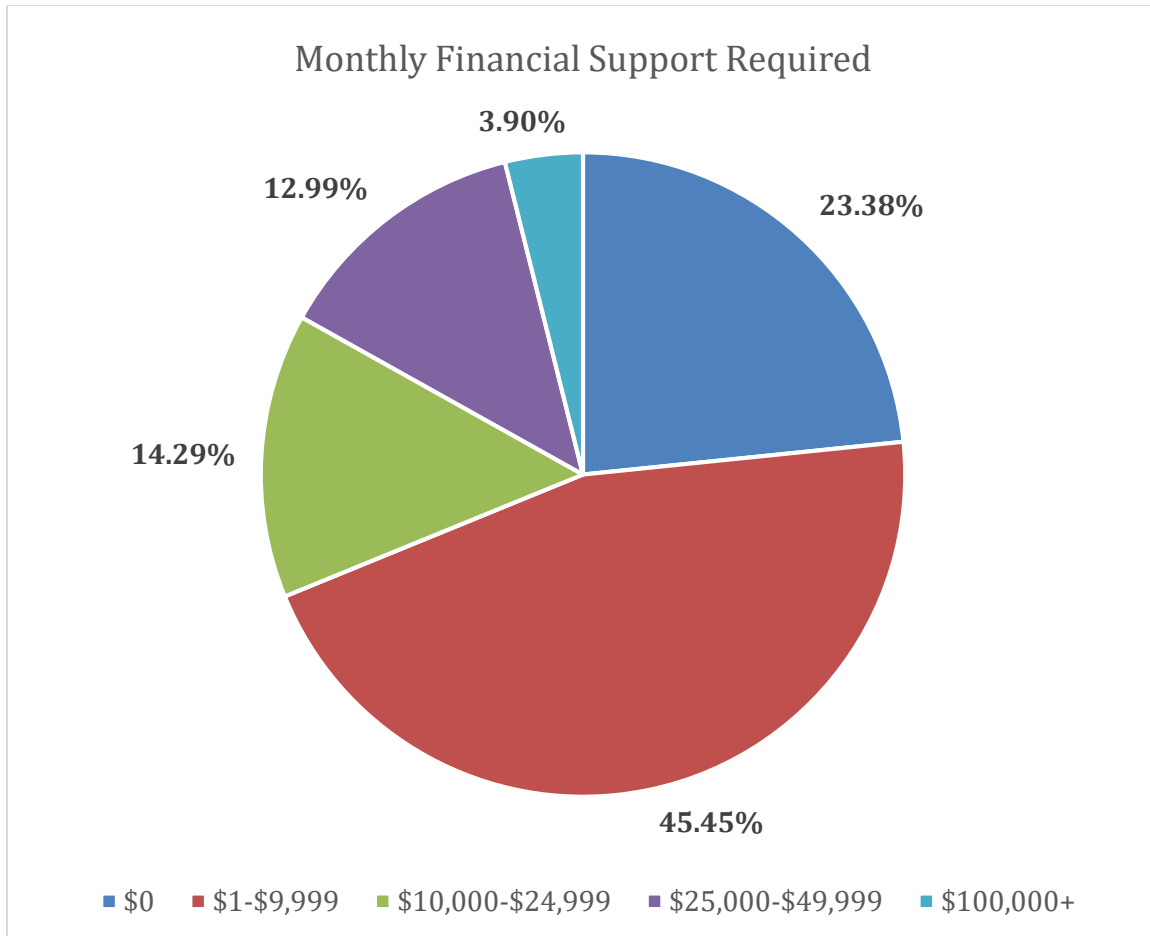

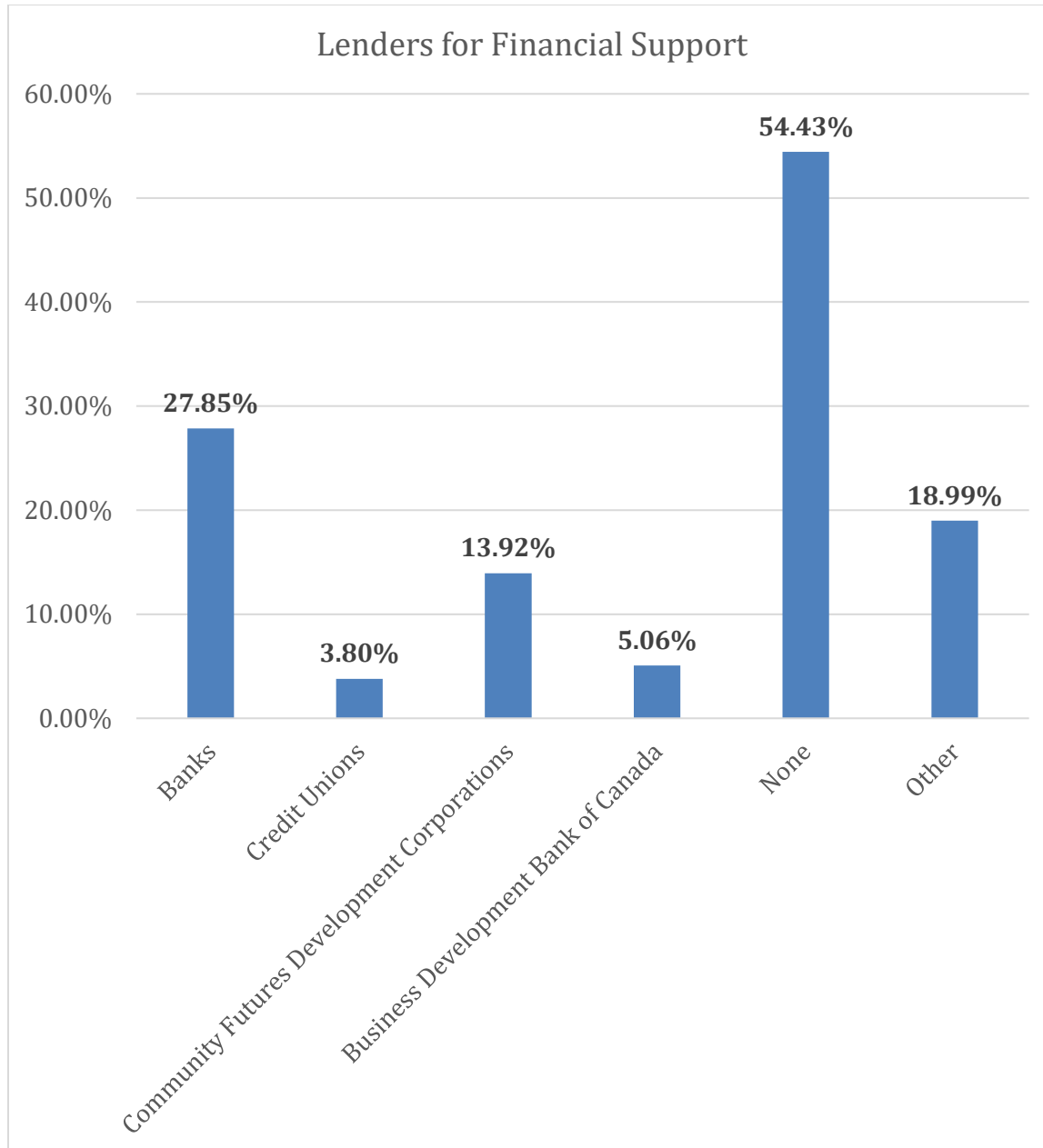

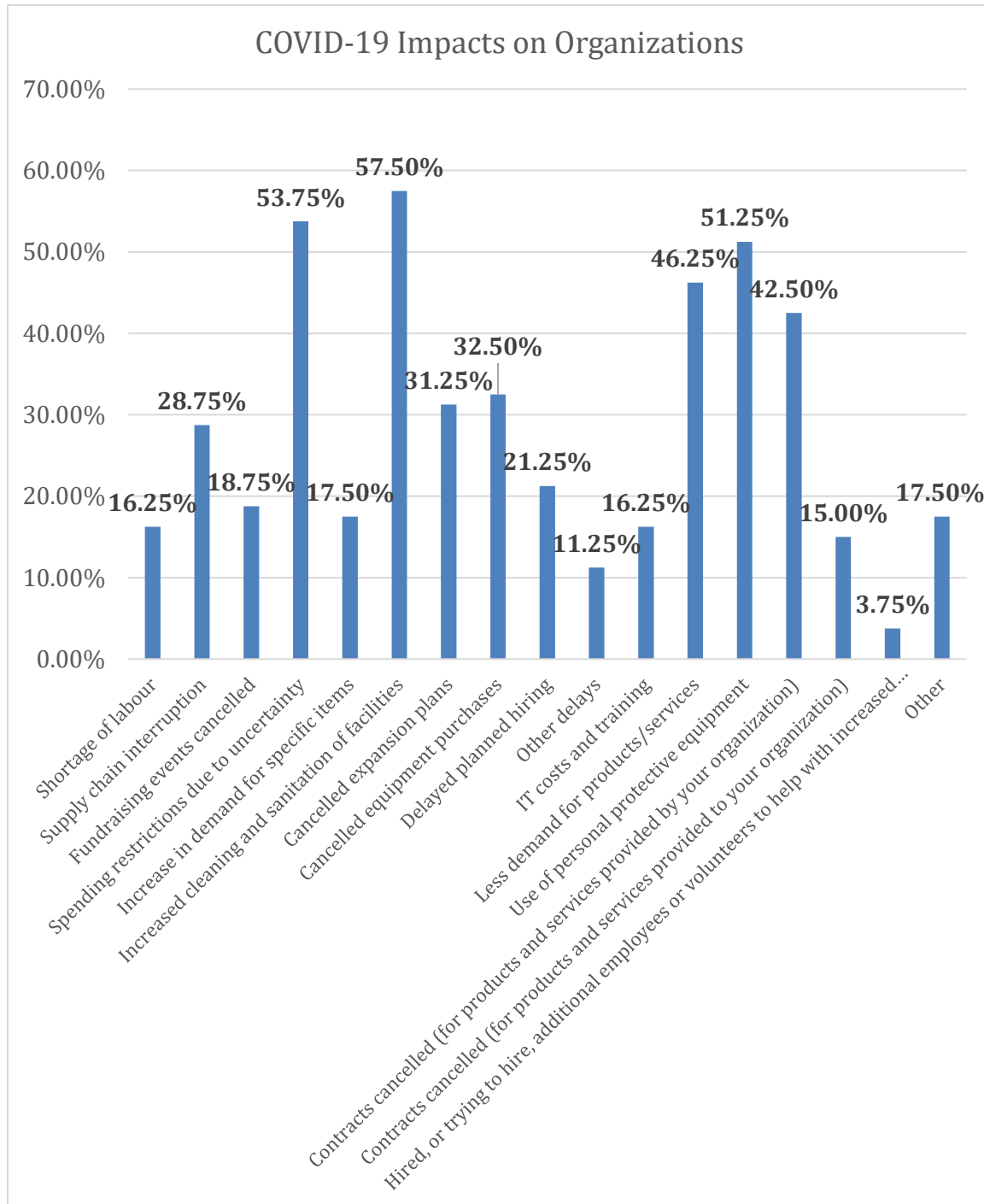

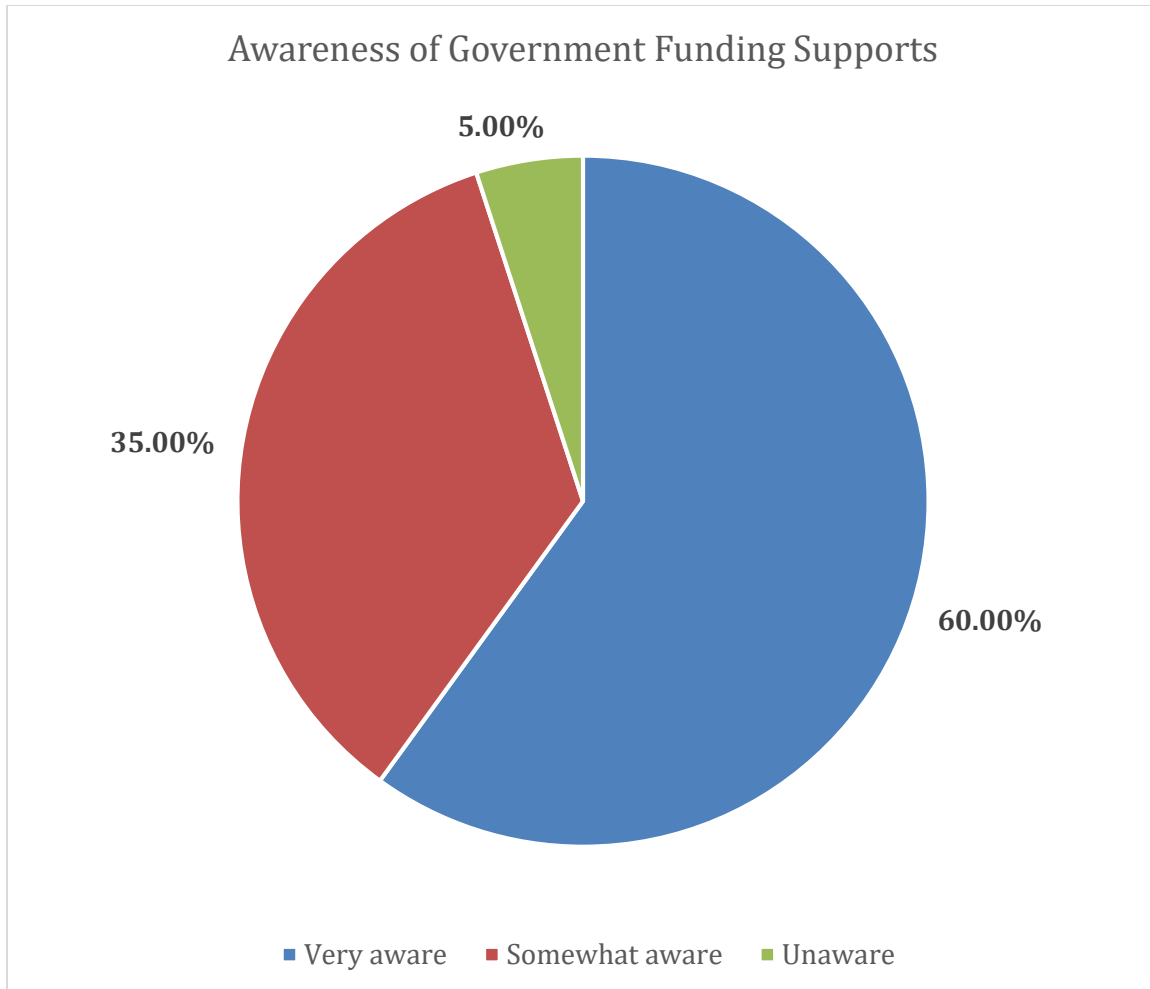

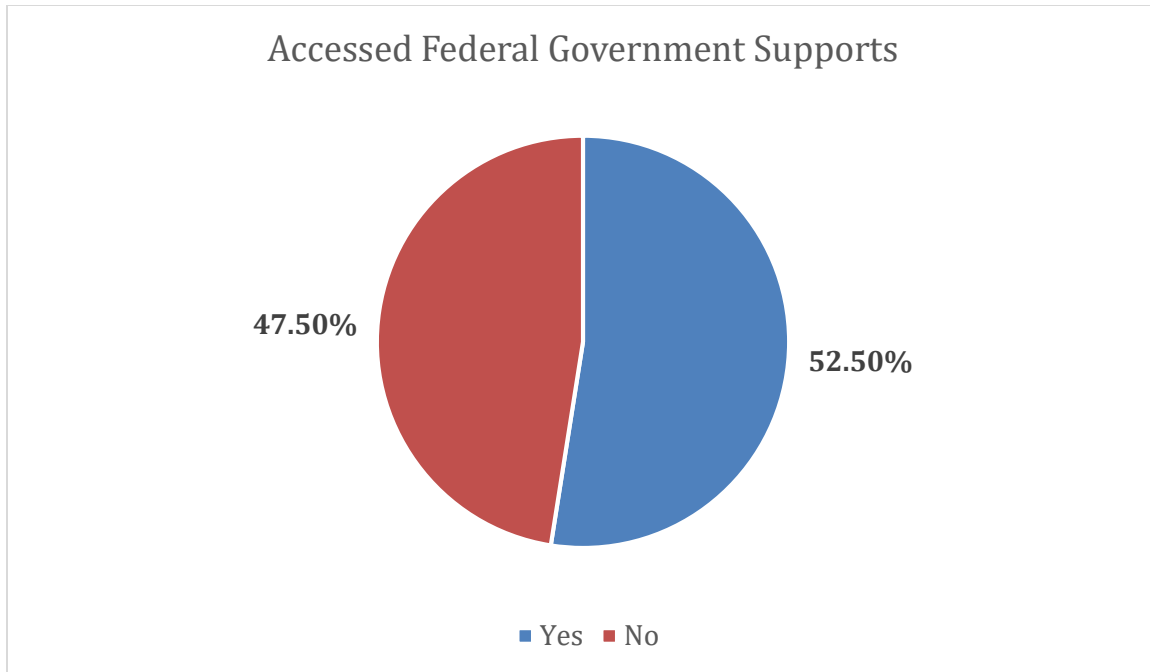

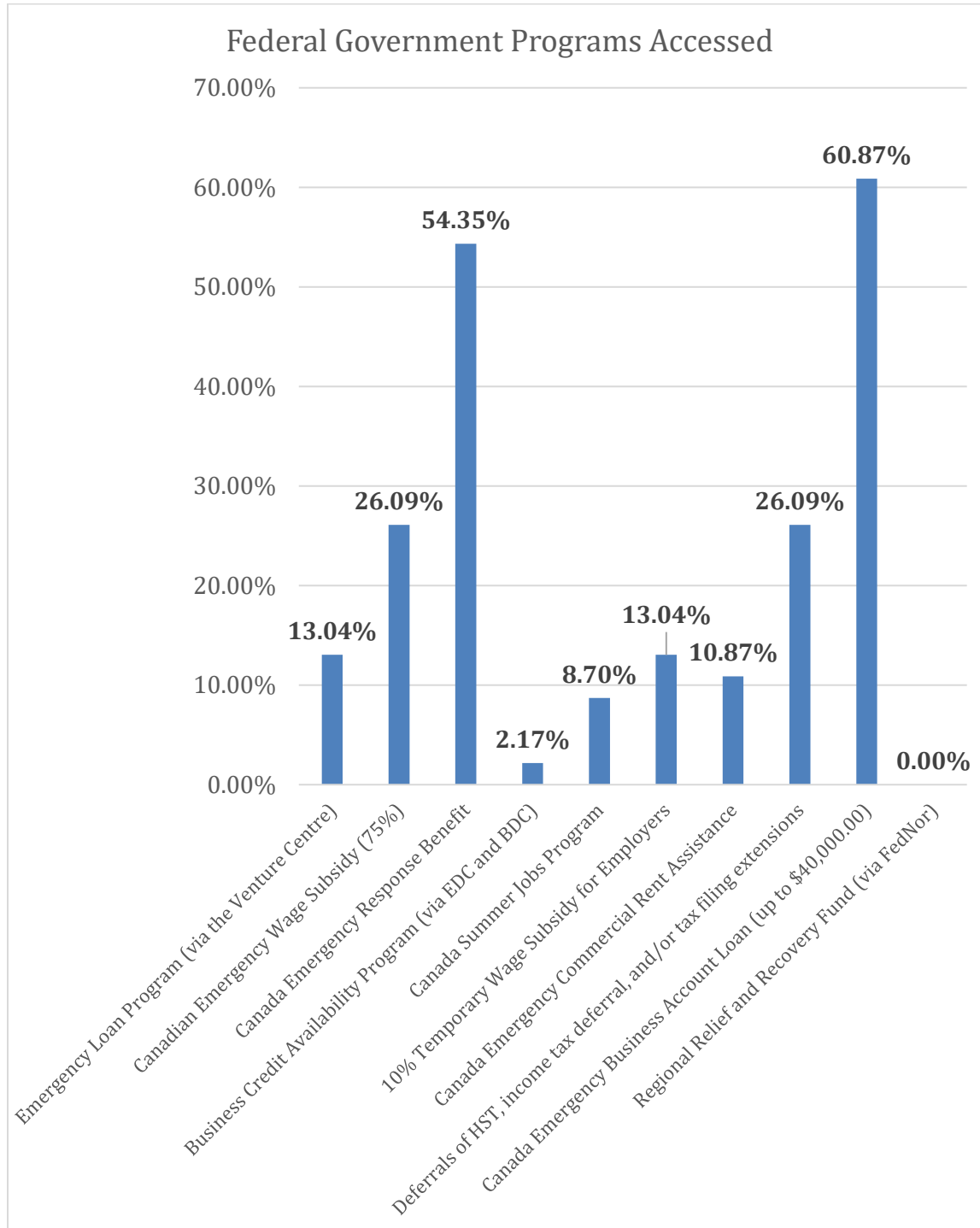

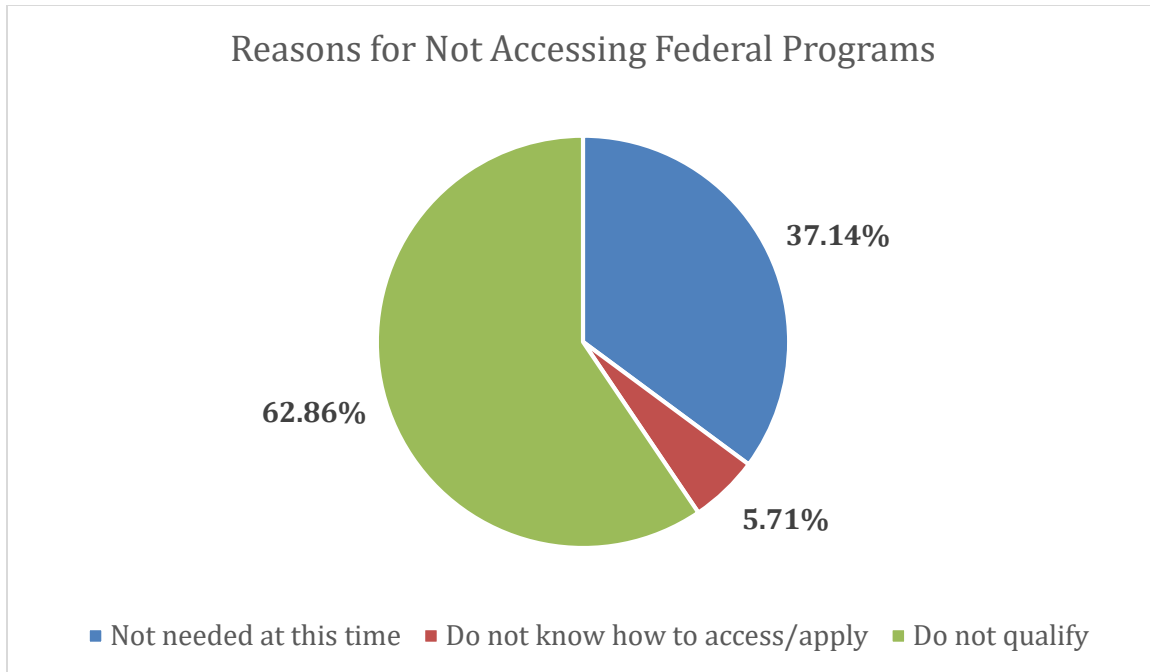

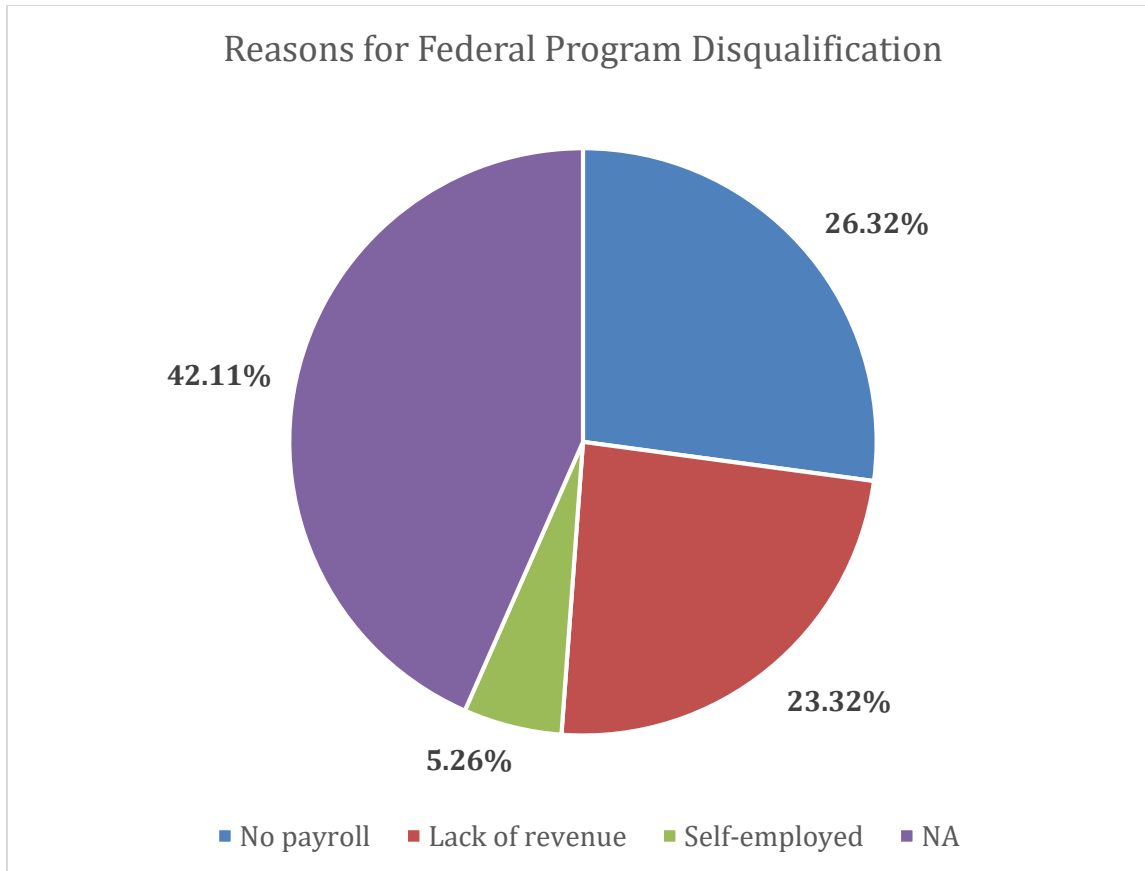

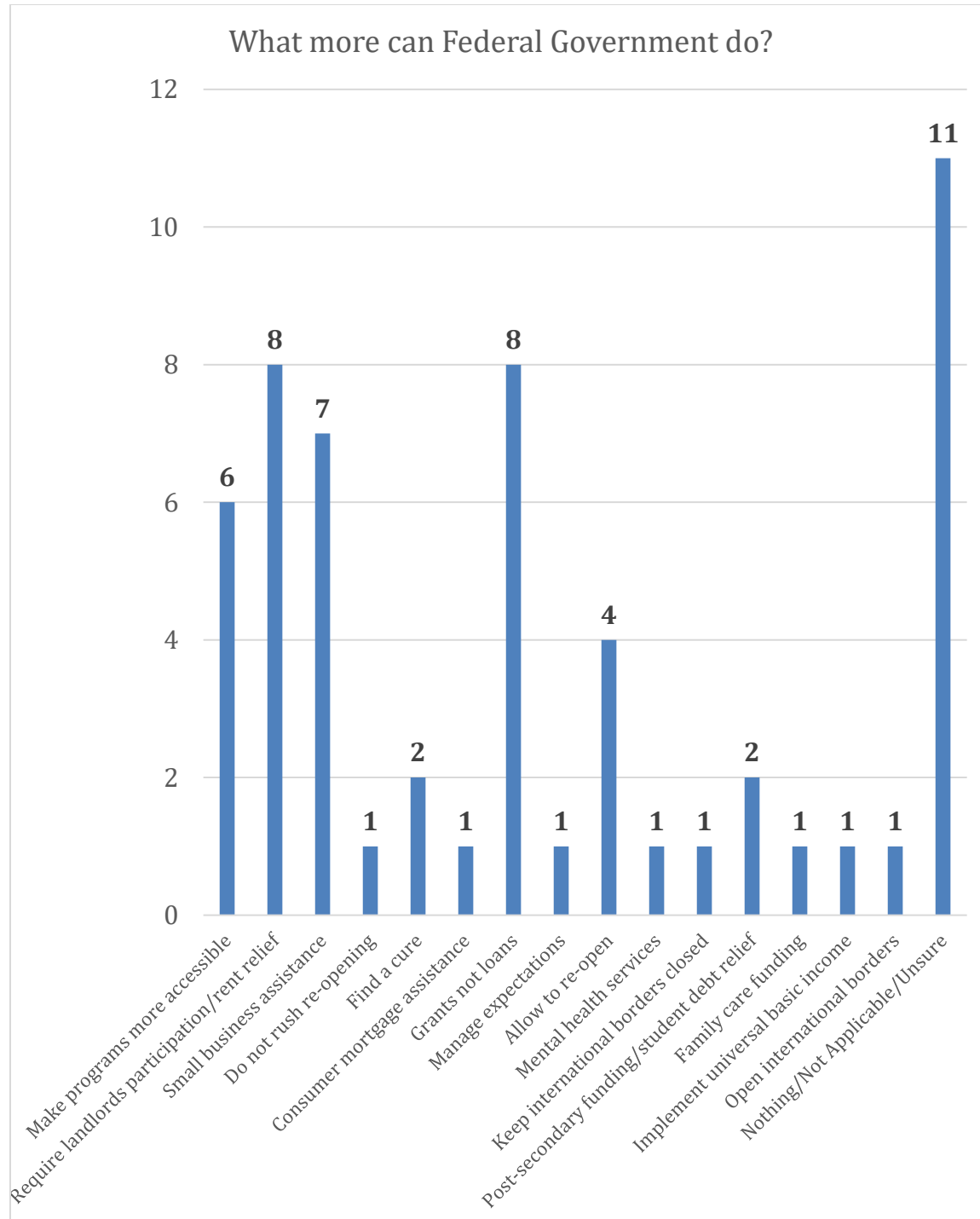
